The product contains quartz (crystalline silica). However, it should be noted that the risk of exposure to crystalline silica would only occur if the material is mechanically drilled, cut or sanded after the product has been applied and cured. The degree of exposure would be similar to the exposure from mechanically drilling, cutting or sanding other cement/stone based products, for example: mortar and prefabricated walls.

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.
